# 8.2 California State Controller-Division of Accounting and Reporting 2009 Prison. 2009 Fiscal Year Single Audit Report Certification and Audit

### 8.3 Approval of Amendment 1 to the Napa County Transportation and Planning Agency (NCTPA) Agreement No. NCTPA 09-02

Board Member Dunbar asked for clarification if deleting the provision for automobile allowance and shifting the annually automobile allowance had an impact to the retiree pension level. Staff reported that there would be

no impact to final retirement compensation as the automobile allowance was already factored into the employee's retirement compensation.

### **PUBLIC HEARING**

9.1 Public Hearing and Approval of Resolution No. 11-17 Authorizing the Application for Federal Transit Administration (FTA) Section 5311(f) (49 U.S.C. Section 5311(f)) with California Department of Transportation

Chair Caldwell opened the Public hearing at 2:03 p.m.

NCTPA initiated a study of its transit services throughout the valley in an attempt to identify patential route realignments and new routes to better address the transit needs of the general public. One new route identified was a commuter connector service between the new Napa Transit Center and park and ride lots and downtown Sonoma.

Staff reviewed the proposed VINE Napa/Sonoma Connection. This service will link Napa VINE's regional routes 10 and 29 (serving Vallejo Ferry and BART) with Sonoma's connections to Golden Gate Transit, Healdsburg In-City Transit, Petaluma Transit, Santa Rosa City Bus and Sonoma County Transit.

Being no Public Comment, Chair Caldwell closed the Public Hearing at 2:13 p.m.

**MSC\* DODD / GINGLES** to **APPROVE** Resolution No. 11-17 authorizing the agency to submit a grant application for FTA Section 5311(f) funds in the amount of \$69,812 towards the partial operating costs of a new commuter express service linking Napa and Sonoma.

## 9.2 Agricultural Worker Vanpool Program (AWVP)

At the February 16, 2011 meeting, the Board directed staff to explore alternatives for the vanpool program for all commuters and return to the Board for direction. One option would be to join the California Vanpool Authority (CalVans), a statewide joint powers organization. CalVans provides vanpools to 14 counties throughout the State. The service provided by CalVans is similar to that currently provided by NCTPA via the Agricultural Worker Vanpool Program.

A representative of CalVans provided a PowerPoint provided of the CalVans program

The Board directed staff to (1) explore the possibility of joining the California Vanpool Authority (CalVans) (2) provide recommendations of how to transfer title of up to four (4) vans and transitioning existing AWVP vans in operation to CalVans and (3) provide economendations of how to dispose of the remaining six (6) AV P ass. Further, that the recommendation for the implementation of a value program for all commuters within Napa County as their origin or destination is to be brought back to the Board for their consideration at the September 7, 2011 meeting.

# 9.3 Authorization to Negotiate Used Bus Purchase

NCTPA's Short range ransit Plan balls for the introduction of newer, commuter type buses to service the route 29 to the Vallejo Ferry and BART. In addition the agency has previously programmed available RM2 bond funds for the purpose of securing buses for this route if/when the opportunity ments. Presently, San Jose International Airport wishes to make available through the Penske Corporation) late model, low mileage, the bases that may meet NCTPA's needs. Board action authorized the executive Director to enter into negotiations for the purchase of 3-5 used buses for use on the Route 29 service.

MSC TECHEL / GARCIA to APPOVE authorizing the Executive Director enter in negotiations for the purchase of 3-5 used buses for use on the course of 3-5 service. Once an agreement has been negotiated between the two parties, the final purchase proposal would come back to the Board for final approval.

Chair Caldwell requested that future reports for items such as this in nature, include the percentage of work to be performed by local companies.
