



The VINE Youth on Transit Quiz Sweepstakes Rules

1. Eligibility

The VINE Youth on Transit Quiz Sweepstakes (the Sweepstakes) is open to legal residents California who are at least fifteen (15) years old at the time of entry. Employees of Napa County Transportation and Planning Agency and other companies associated with the promotion of the Sweepstakes, and their respective parents, subsidiaries, affiliates and advertising and promotion agencies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Sweepstakes is subject to federal, state, and local laws and regulations.

2. Sponsor

3. Agreement to Official Rules

Participation in the Sweepstakes constitutes entrants full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. Winning a prize is contingent upon being compliant with these Official Rules and fulfilling all other requirements set forth herein.

4. Sweepstakes Period

The Sweepstakes begins on March 1, 2015 at 8:00 am PST and ends on March 31, 2015 at 5 pm PST (the Sweepstakes Period). Entries that are submitted before or after the Sweepstakes Period will be disqualified. 5. How to Enter

Online: This method of entry will be available by visiting the website <https://www.surveymonkey.com/s/YouthonTransit> and following the directions provided to fill out the entry information, and submit.

Via Mail: This method of entry will be available for the entire Sweepstakes Period. On a 3x5 card, handprint your full name, complete address, phone number (including area code) date

of birth and email address (optional) and mail in an envelope with proper postage affixed to: VINE Youth on Transit, 625 Burnell Street, Napa, California, 94559 Mail-in entries must be hand-printed and mailed in separately. All mail-in entries must be postmarked by March 31, 2015.

Limit one (1) entry per person, per email address, for the duration of the Sweepstakes Period, regardless of method of entry.
