Public Comments

Members of the public are welcome to address the Committee, however, under the Brown Act Committee members may not deliberate or take action on items not on the agenda, and generally may only listen.

SUBJECT: AB 361 Requirements for Remote Public Meetings

RECOMMENDATION

That the PCC approve holding the January 6, 2022 PCC meeting and the March 3, 2022 PCC meeting via teleconference as the existing emergency declaration continues, which permits relaxed remote meeting allowances in accordance with AB 361.

BACKGROUND

AB 361 allows local legislative bodies to hold remote meetings during a proclaimed state of emergency, if state or local officials have imposed or recommended measures that warrant holding meetings remotely.

On September 27, 2021 the Napa County Executive Officer and Public Health Officer issued a recommendation that all public boards and commissions that wish to continue meeting remotely in order to help minimize the spread and transmission of COVID-19 be permitted to do so.

NVTA staff is monitoring the status of the Governor's state of emergency proclamation, state and local orders related to social distancing, and health and safety conditions related to COVID-19, and confirms that said conditions persist and warrant remote only meetings pursuant to the provisions of paragraph Government Code section 54953, subdivision (e)(3). Staff recommends the TAC consider extending the time during which it may continue to meet by teleconference without compliance with paragraph (3) of subdivision (b) of section 54953 of the Brown Act.

EXECUTIVE SUMMARY

This report summarizes the Vine's operational changes during the second quarter of FY 2021-22 and gives a preview of upcoming plans for the transit system. Second quarter FY 2021-22 data was not available in time for this agenda and will be presented at the next Paratransit Coordinating Council (PCC) meeting in March 2022.

FISCAL IMPACT

BACKGROUND & DISCUSSION

Summary of Operational Changes

In March 2020, NVTA made several service changes in response to reduced ridership demand associated with the coronavirus pandemic and public health orders issued by the State and County of Napa. Specifically, service hours were reduced, fare payment was suspended, seat spacing was introduced, and buses began using rear door only boarding whenever feasible to ensure the safety of riders and drivers.

NVTA has done a series of changes, the most recent on August 15, 2021, to begin to restore some of the service suspended during the COVID-19 pandemic. Then on November 21, 2021, NVTA made minor changes to its local and regional route timetables to improve efficiency and decrease the number of missed trips due to driver shortages. Specifically, NVTA made minor changes to the timetables for the local Routes S and W along with the regional Routes 11X, 11 and 21. In addition, NVTA expanded its fixed route service on the Route N to better serve transit-dependent communities of Rohlffs Manor, Redwood Retirement Residence and Pueblo Vista Magnet School.

The timetables on all other routes will remain the same. NVTA continues to operate the local routes N, S, W and E to offer a convenient option for riders in the high demand areas, however, on-demand services will only be offered in lower demand areas where the fixed routes N, S, W, and E do not operate.

NVTA is hoping that these changes are temporary until we can fully staff our driver roster. In the meantime, thank you for your patience as we navigate these turbulent times.

NVTA continues to follow recommended health and sanitation requirements. As mandated by the Transportation Security Administration, face masks are required on Vine vehicles, at bus stops, and at all facilities. Vine buses are thoroughly sterilized each day and frequently touched areas, such as handrails, are cleaned several times during the day.

Update on Senior Transportation Needs Assessment

In response to requests from PCC as well as the Napa County Committee on Aging, NVTA developed a draft Scope of Work. The idea was that NVTA would release the RFP to their on-call planning consultants list and that Napa County would pay the cost of the consulting work. The Napa County Board of Supervisors at their meeting on November 16, 2021 determined that the priority community need for the local American Rescue Plan Act (ARPA) funds should be childcare so the County will not be providing funding at this time for the Senior Transportation Needs Assessment. NVTA is working internally to identify resources in its FY 2022-23 budget cycle for this work because NVTA would like to move forward with releasing this RFP.

EXECUTIVE SUMMARY

This memo provides an update on NVTA's Transit Ambassador and Shared Vehicle Programs.

FISCAL IMPACT

BACKGROUND & DISCUSSION

Vine Transit Ambassador Program

This program has been in existence in Napa for over 20 years. It provides new Vine Transit riders with a personalized one-on-one orientation on how to use public transit in Napa County. The new rider is provided orientation by a trained volunteer (transit ambassador), who goes through classroom training and has at least one-year of experience riding the Vine transit system. An ambassador will stay with each rider until they feel confident and can navigate the Vine transit system independently. Trainees of this program eventually become the Trainers that provide this valuable service.

Right before the pandemic, in March 2020, there were five active transit ambassadors. The COVID-19 pandemic has suspended the program. However, NVTA staff has gone

on a few requested ride-alongs to serve as ambassadors on an ad-hoc basis over the last 22 months.

NVTA is gearing up to re-instate the program once there is greater demand for ride-alongs. The goal is to bolster the program by increasing recruitment efforts in different communities, such as the college, high school students, major employer(s), non-profit organizations, etc. Staff is researching other transit agencies to learn how similar ambassador programs have navigated through the COVID-19 pandemic.

Shared Vehicle Program

This program was created expressly for 501(c)(3) organizations that serve the elderly and/or disabled. NVTA lends wheelchair accessible vehicles to non-profit or public agencies/organizations that need to transport the elderly and/or persons with disabilities.

Here is a step-by-step process on how the program works:

- 1) An organization/agency qualifies for the program
- 2) The organization/agency identifies a prospective driver from their workers' compensation policy
- 3) NVTA performs a background check and drug testing on the driver
- 4) Once the driver passes the background check and drug testing, NVTA provides training to the driver
- 5) The organization/agency provides proof of insurance for general liability and insurance for hired and non-owned auto liability
- 6) After all the steps above have been complete, the organization/agency can schedule a time/date to borrow a vehicle. The organization/agency is in charge of picking up and returning the vehicle, submitting trip paperwork and replacing the gasoline used. Most vehicles require a Class B driver's license.

Currently, there are three shared vehicles in use. Only one is consistently used by Collabria Care. Since they use it consistently, the vehicle is stationed in their parking lot. The amount of miles the vehicle drove in Fiscal Year 2020-2021 (July 1, 2020 – June 30, 2021) was 2,592 and the ridership was approximately 468.

Feedback

As ridership continues to return towards pre-pandemic levels, NVTA is seeking to reinvigorate these two programs, especially the transit ambassador program. Staff would value your ideas, feedback, and questions to help us bolster the utilization rates.
